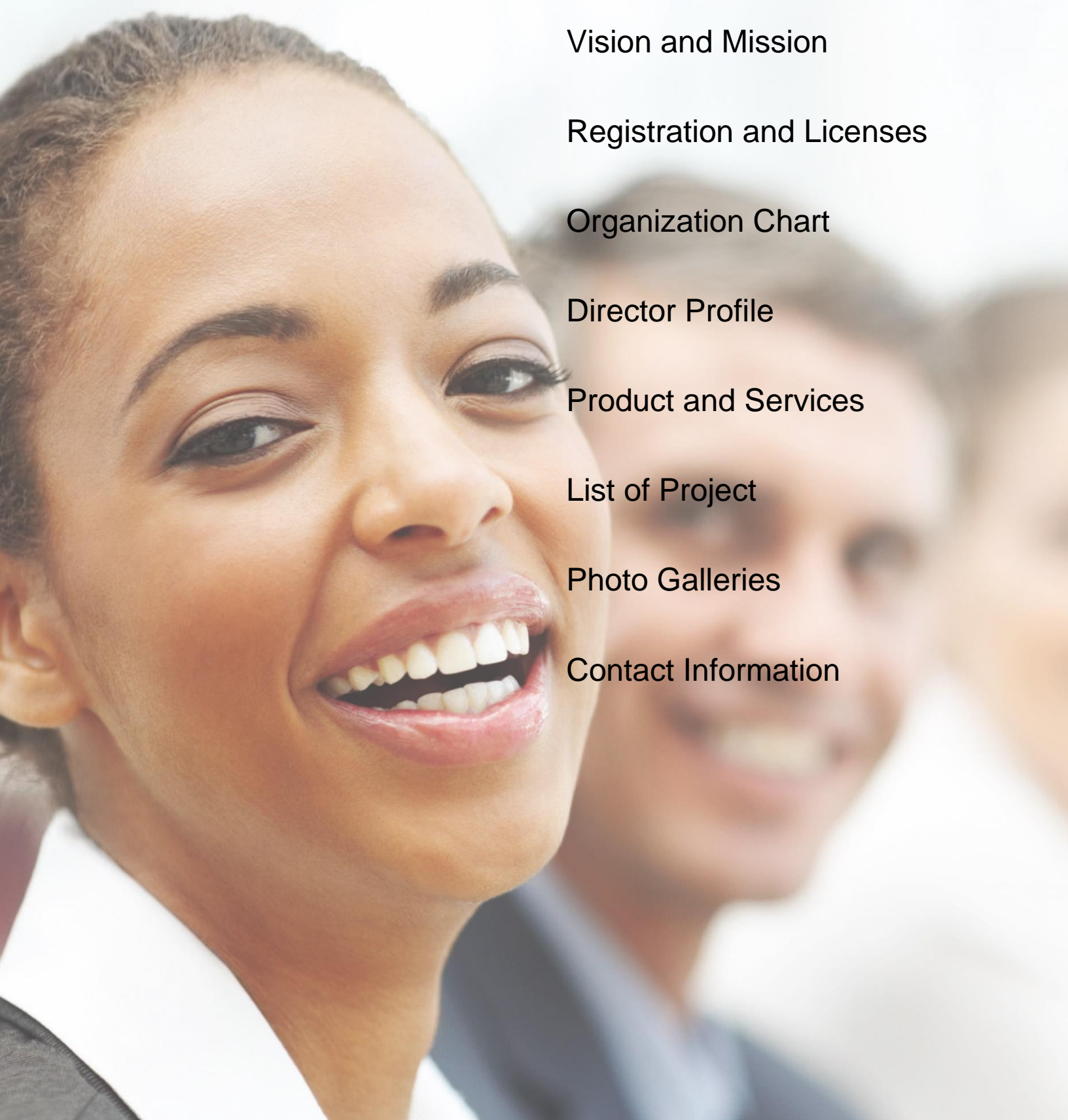



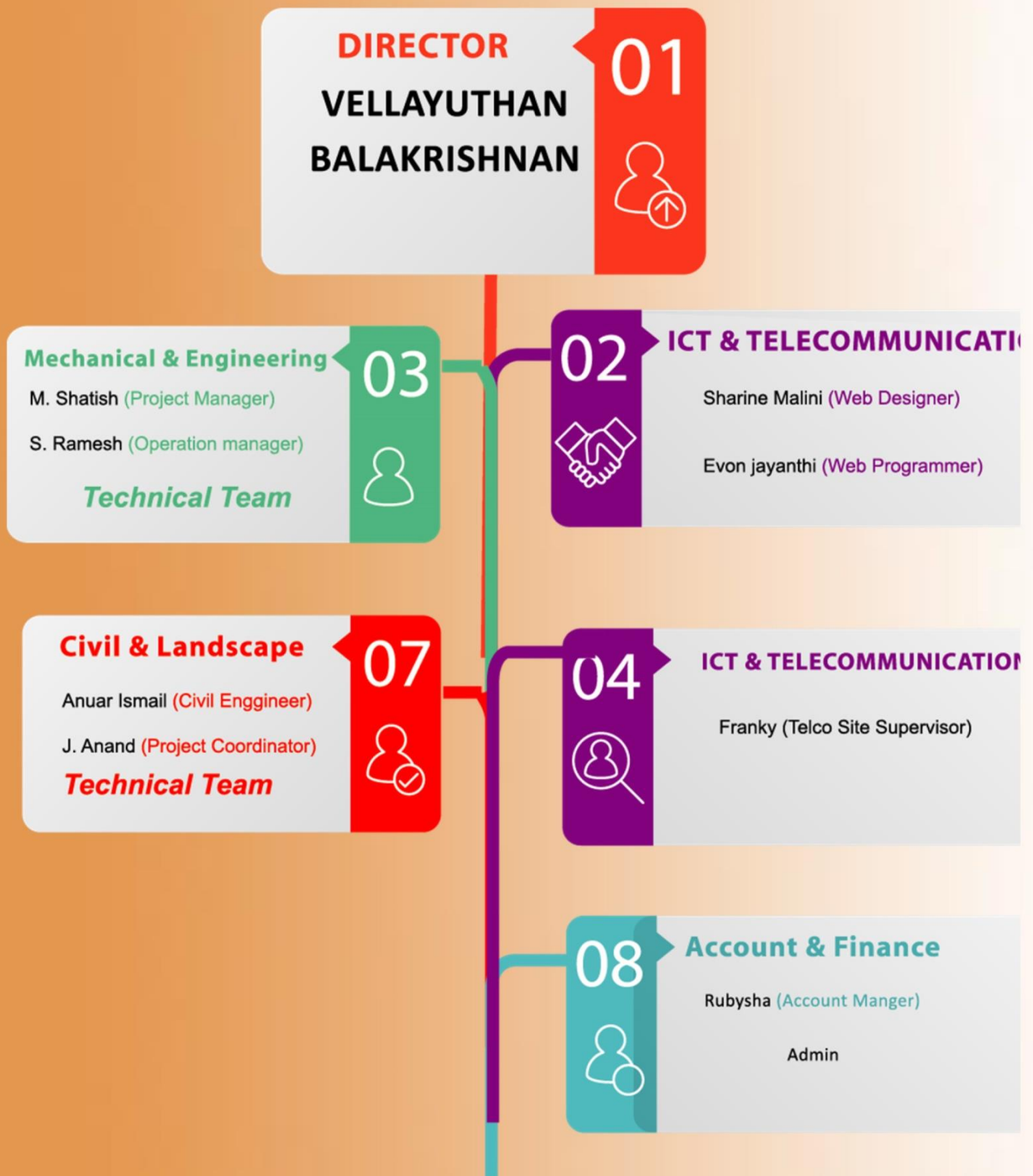
Director Profile

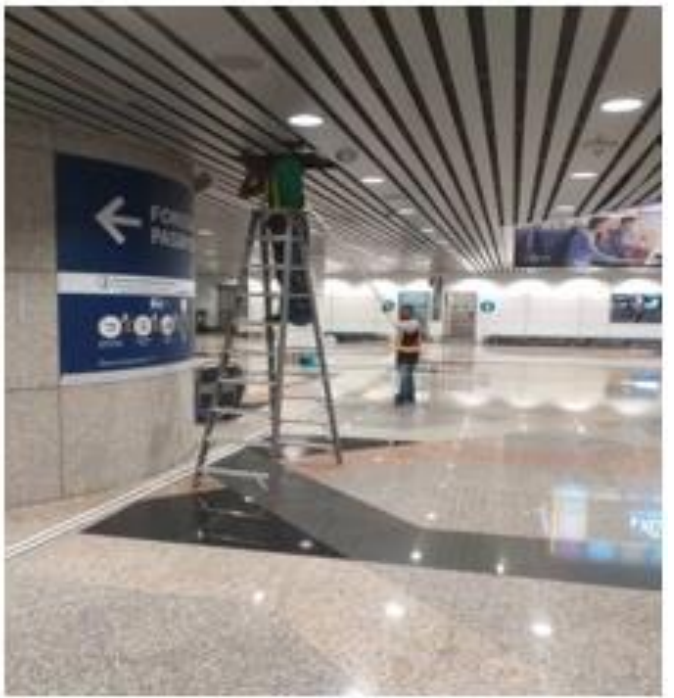

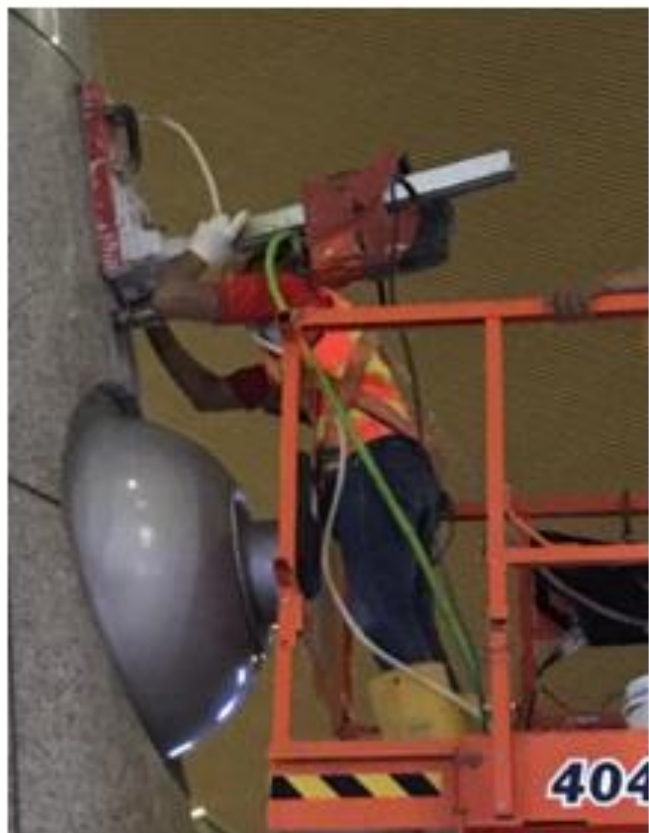

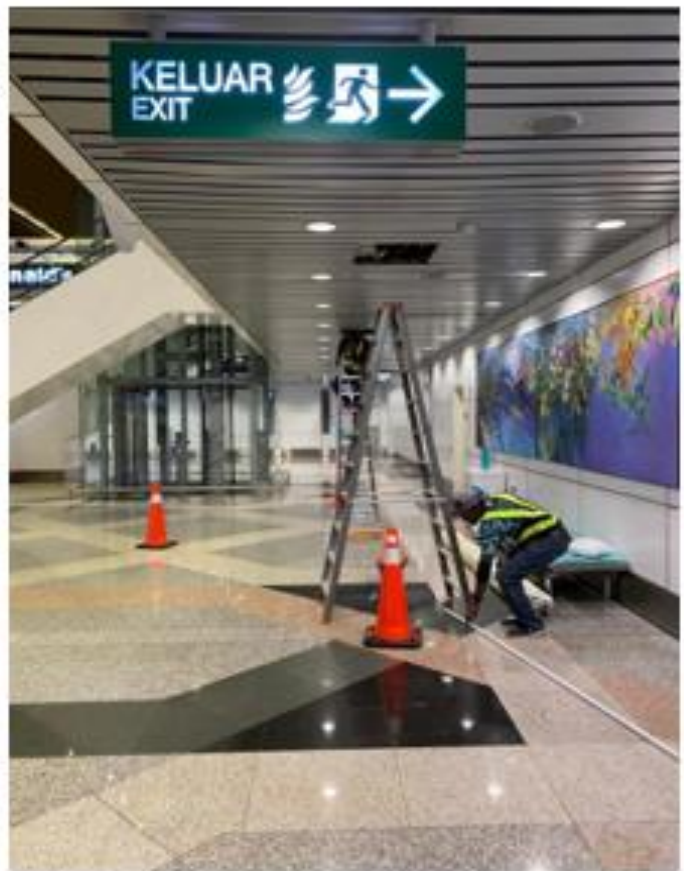
